I/ we understand and agree to the following terms and conditions:

- I shall deposit with the condominium upon signing this agreement, a refundable security/ damage deposit in the amount of \$500.00 by money order or certified cheque, payable to TSCC 2444.
 This amount will be refunded upon completion of the move, provided that I have not caused any damage to the common elements of the condominium.
- 2. I shall only use the elevator during the term of the reservation.
- 3. If the elevator service runs past the designated scheduled time, the Resident will be responsible for paying the condominium to assist with the elevator booking and the resident will be charged \$50.00 per hour for this service.
- 4. I shall notify the Property Manager or Front Desk staff and request an inspection of the elevator immediately prior to using the same. Upon completion of the move or delivery, I shall forthwith request a re-inspection of the elevator and adjacent common elements.
- 5. When damage has occurred, either to the elevators or any other parts of the common elements (e.g. corridors and exterior portions of suite doors) due to activity during this Reservation, the registered unit owner and occupant of the said unit at the time of the damage was caused, shall be jointly and severally responsible to the condominium for the cost of repairing any such damage. Payment for the damage shall be deducted from the security deposit (\$) and any costs higher than the damage deposit shall be recovered from the owner and occupant within 10 days upon demand. Residents breaching these Moving Rules are subject to forfeiture of part or all of the damage deposit.
- 6. I shall take reasonable precautions to prevent unauthorized entry into the building during the term of the reservation.
- 7. I shall not obstruct corridors and elevator lobbies prior to, during or after the term of the reservation.
- 8. I agree that special care will be taken with regard to any mirrors that are present in the elevators. I agree that the protective pads shall be in place prior, during and until the completion of the final inspection.
- 9. I agree that if the garbage truck is on site, the moving truck will be moved for the time being of the garbage or recycling collection.
- 10. The condominium, concierge and management are not responsible in the event the service elevator is not available for your move-in, move-out or delivery due to technical breakdowns, or due to various other reasons, which are beyond our control.
